Role of the Co-Leading Organizations

Co-lead organizations assume overall responsibility for coordination of the Action Coalition's activities. These organizations assemble and oversee the activities of nursing and non-nursing leaders at the local, state, and regional levels to implement the recommendations of the IOM report *The Future of Nursing: Leading Change, Advancing Health*. This includes engaging a broad range of stakeholders and leading them toward common goals, building an effective infrastructure, securing resources, serving as a communications contact, guaranteeing proper compliance with lobbying intervention, and providing report requirements.

The *Campaign's* focus is on the consumer, not simply on nursing, and so Action Coalitions must have at least two co-leading organizations. One must have as its core business the promotion of nurses or nursing. This co-lead contributes a deep knowledge of state nursing issues and nursing groups in an effort to organize existing or new collaborative efforts.

The other co-leading organization must be involved in a field outside of nursing. The role of the non-nurse co-lead is to be a strong partner, linking nursing organizations to leaders and stakeholders in other fields while also demonstrating how partnering with nurses can improve health and transform health care.

The success of *Campaign for Action* and Action Coalition efforts will depend on the willingness of diverse stakeholders to partner with each other and nursing organizations to focus on health, expand access, improve quality, and contain costs. The non-nurse organization that co-leads the Action Coalition must carry this message and help other non-nursing organizations understand where they fit into the Coalition's efforts. We encourage the nursing co-lead to work with insurers, retail clinics, large employers, consumers, and health provider organizations or associations. These sectors understand that nurses deliver the best possible care to improve the health of their employees, members, and families, and are committed to creating lasting change.
